Using data from customs declarations entails the following benefits:

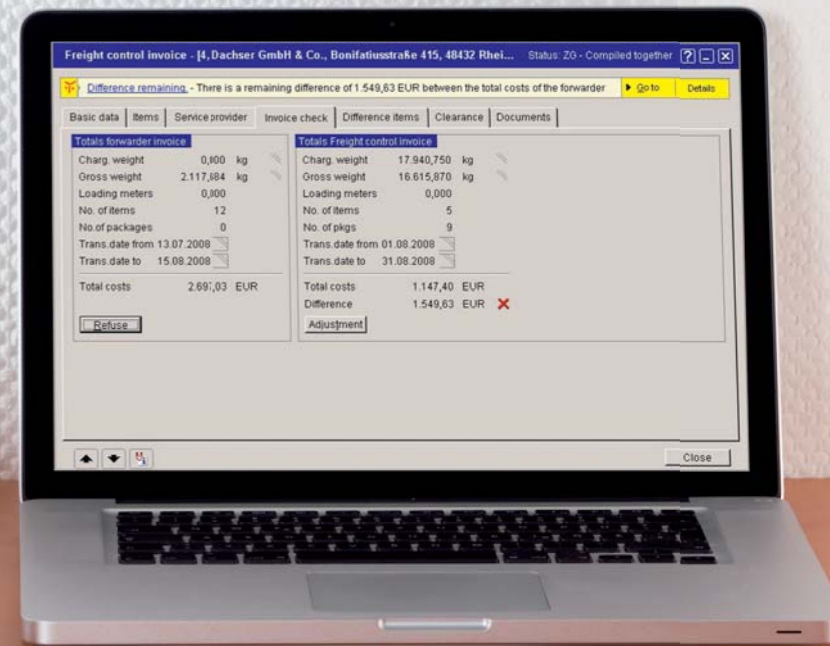

AEB's Invoice Auto-Audit solution provides added value by introducing transparency to the often confusing array of cost structures. Precise costs are calculated in advance, simplifying and automating the invoice verification process. Expected invoice amounts are compared with those actually billed.

Checking bills is tiresome. Incorrect bills are often not noticed. Even in today's trading community, the majority of shippers maintain their rates in spreadsheets and manually calculate their consignment freight charges. In fact, some of them make these calculations only after they receive their freight forwarder's invoices, just to double-check if they have been billed correctly. To make matters worse, they do this only on a random basis before passing the invoices along to accounts payable for processing.

Good idea: check all forwarder invoices yourself. Research has indicated that about 7% of all amounts are invoiced incorrectly. Thus, the transport costs affect the

revenues of many orders. In other words: saving here means greater cost-effectiveness. One of the most laborious activities for shippers is checking whether they have been billed correctly by the freight forwarders for a certain period.

Better idea: let them be checked. ASSIST4 Freight Management gives you efficient control over your transport costs. It lets you know in advance exactly what your costs will be and provides you with self-billing and e-billing options to automate your invoice processes while giving you complete control over costs throughout the entire process. It doesn't matter whether you calculate your freight costs in advance to support sales or during goods issue/receipt.

Core Capabilities

Cost Comparability
All freight forwarders' freight quotes and tariffs are maintained in one system. Invoice Auto-Audit calculates freight costs for all consignments for all modes of transports based on the freight quotes.

Consolidated Reports
This core feature allows shippers to consolidate their transportation legs for a given freight forwarder at the end of the month/period in a report and compare that against the freight forwarder invoices received.

Cost Simulations
A set of "what if" options allow simulations for probable cost development under presumed changes of parameters. It permits you to generate reports and analyses on future freight cost development.

Cost Reallocation
Invoice auto-audit calculates the reallocation of costs to business units, cost centers etc.

E-Billing
Freight forwarder invoices can be received electronically and automatically compared against all related consignment freight charges.

Discrepancies Highlighted
All invoicing errors found will be flagged in a discrepancy report.

Seamless system integration

Auto Invoice Correction

Additional Services

Self-Billing
